Preference will be given to prior year vendors on the spot they have occupied the prior year if payment is received by May 31. New vendors and vendors that pay after May 31 will be assigned spaces in the order in which payments and completed vendor agreements are received.

VERNAL'S DINOSAUR ROUNDUP RODEO



Exhibitor hereby agrees to abide by the following rules and regulations.

No booth will be reserved or allowed to be set up without this agreement signed.

1. **Liability and Insurance** – The Dinosaur Roundup Rodeo Committee, exhibit facility, and the staff of the same will not be held responsible for the safety and property of the exhibitors or their agents from theft, damage by fire, accident or other causes. Insurance on the exhibitor's property is the responsibility of the exhibitor. **NOTE: All Vendors will be required to submit a CERTIFICATE OF INSURANCE showing liability coverage.**
2. **Displays** –Are to be contained within the exhibit booth area without projections which will disturb other exhibitors or the flow of traffic.
3. **Solicitation** – Exhibitors are expected to conduct business within the confines of their booth space. Advertising and/or solicitation by persons not holding booth/space is prohibited.
4. **Use of Hazardous Materials** – Electricity and the use of flammable materials must conform to all State and Local regulations. Firearms must be non-operable, with firing pin removed, or other safety precautions to ensure the safety of others. NO live ammunition, powder, or primers will be allowed in the Exhibit area. NO gasoline engines will be allowed to operate.
5. **Noise level-** In the Exhibit hall, we must control the noise level of demonstrations in booths. If your booth in the Exhibit hall interferes with other exhibitors, we will ask you to curtail the activity immediately. The Dinosaur Roundup Rodeo Committee has the right to limit the noise of any booth and the right to remove an exhibitor for noncompliance.
6. **Damage** – Any damage to the property is the responsibility of the exhibitor causing the damage. Any restitution for such damage remains his/her responsibility.
7. **Compliance with Ordinance** –All exhibitors shall comply with all local, county, state and federal police, fire, health, and safety laws. All exhibitors shall fill out the necessary paperwork for all tax reporting purposes.
8. **Reassignment of Booth space-** No booth space or other space rented out shall be shared or sublet to others without the written consent of the Dinosaur Roundup Rodeo Committee. All persons who share a booth must sign the Regulations Agreement and comply with the same. If space comes vacant for any reason, such space reverts to the Dinosaur Roundup Rodeo Committee for further assignment.
9. **Indemnification**—Exhibitor will erect and operate displays in manner which does not injure the Exhibit area, and will reimburse the management of the Exhibit area and/or the Dinosaur Roundup Rodeo Committee for any loss or damage which the exhibitor causes to the Exhibit area. The exhibitor agrees to defend , protect, hold harmless, and indemnify the Dinosaur Roundup Rodeo Committee against all actions, liabilities damages, losses, expenses, debts, taxes, fees, charges, assessments, and other claims which may be caused by, arise out of, or are in any way associated with our contribute to directly or indirectly, by any act, omission, negligence, fault or violation of any law or regulation by the exhibitor or any of the exhibitors officers, employees, agents independent contractor, volunteer, guests or visitors including but not limited to the costs of the investigation, processing, litigation, or setting any such claim the Dinosaur Roundup Rodeo Committee reasonable attorney fees.
10. **Attorney's fees-**If either the exhibitor or the Dinosaur Roundup Rodeo Committee brings any action with the respect to this agreement or the Dinosaur Roundup Rodeo Committee, the unsuccessful party to the action will pay the reasonable attorney fees and legal costs of both parties, as they are approved by the court having jurisdiction over the action.
11. **Impossibility-** If the Dinosaur Roundup Rodeo Committee determines fire, flood, weather, strikes. Civil disorder, or other circumstances beyond its control making it impossible or inadvisable to carry on the exposition with due regard for the safety and welfare of exhibitors and visitors, then this contract will, at the election of the Dinosaur Roundup Rodeo Committee, become void and terminated. The Dinosaur Roundup Rodeo Committee will refund the rents paid by the exhibitor, but the exhibitor waives any other claims for damages or compensation as a result of such termination.
12. **Choice of Law and Venue-** The contract will be governed by the laws in which the Dinosaur Roundup Rodeo Committee is located. Any action with the respect to this contract must be brought in the county which it is located.
13. **Acceptance of Regulations** – By signing this agreement the Exhibitors accept and agree to abide by these regulations, and agree to abide and be bound by decisions made by the Dinosaur Roundup Rodeo Committee with the respect to matters not covered by these regulations. The Dinosaur Roundup Rodeo Committee shall have the right to evict any applicant from the Dinosaur Roundup Rodeo Committee for violation of these regulations or other just cause and no refund of any fees will be rewarded.

If payment is not made by the exhibitor as per this agreement, event management may release said space without notice or refund. All exhibit fees are non-refundable. Exhibitor remains liable for payment of all fees including any balances and advertising commitments in the event of cancellation or in the event show management must resell said space. Event management reserves the right to move exhibits and to advertise and promote exhibitor's products or services in any manner it deems beneficial for the event. Exhibitor agrees to pay a \$50.00 charge on any payments not received when due. Exhibitor agrees to pay all reasonable attorneys' fees and all other costs incurred, should collection actions be required. The management assumes no risk. By acceptance of this agreement, the exhibitor expressly releases the management from any and all liability for any damage, injury, or loss to any person or goods which arise from the rental and occupation of show space. Exhibitor is prohibited from breaking down exhibit or display any time prior to completion of show. Exhibitor must be set up and ready for show no later than 5pm each night of the event. By signing below you agree to all terms. Vendors are responsible for the supply of all displays, equipment, canopies for those that are not under tents or other items needed for their individual participation during the festival. Canopies, displays and other equipment related to the vendor's booth must be aesthetically pleasing and conform to the general atmosphere of the festival and/or the standard of the Rodeo Committee. Any canopies, displays or equipment used must fit within the allotted booth spaces. Any items that do not fit within that space will not be allowed.

Cancellation:

In the event Vernal's 2022 Dinosaur Roundup Rodeo is cancelled, all Trade Show application fees will be refunded within 5 business days in the same method payment was received.

Electricity:

All booths will have access to 120v single phase electric per 10x10 spaces. Additional electric needs will be dealt with on a case-by-case basis and fees will be accessed accordingly.

Exclusive Products:

All vendors are **required to sell Coca-Cola products only, including Dasani water if Coca-Cola is a sponsor of the 2022 event.**

Our local Coca-Cola distributor will be available to purchase product. The distributor will buy back all full cases of unused product purchased directly from them.

Exhibit Hours:

The exhibit area will be open each day at 5:00 p.m. and will remain open until 1 hour after the last event of the performance. Exhibitors must open for each rodeo performance. (Thursday, Friday, & Saturday)

Exhibitor Passes:

Each exhibit will receive two passes. Passes must be worn at all times or access will be denied.

Insurance:

A Certificate of Insurance showing liability coverage must be received by July 1.

Lighting:

It is recommended that exhibits provide their own lighting. Christmas lights or other non-distracting lights are recommended.

Parking:

There will be designated parking for those Exhibitors in located in the far west parking lot. No trailers or commercial vehicles will be allowed to park on the east side of the west parking lot from 4:00 p.m. the day of the Rodeo performance to 12:00 a.m. on the final day of performance.

Prohibited Products:

Vendors will not be allowed to sell products that could be disruptive to the rodeo performance or hazardous to livestock or spectators. This includes, but is not limited to: laser pointers, weapons, whistles, horns, etc. The rodeo committee is the final authority on any products that may pose problems.

Setup and removal:

All exhibit booths may begin setup on the Wednesday before the Rodeo performance begins. Vehicles will be permitted to drop off merchandise on that Wednesday starting at **NOON** and each day of the event until 3:00 p.m. Removal of exhibit may not begin until after the close of exhibit hours on the final performance day. Booths must be cleared out by the following Sunday by 6:00 p.m.

Telephone:

Telephone service is not available.

Tents:

Tents will not be provided. Exhibitors are responsible for providing their own.

Security:

Security is not provided. Each exhibitor is responsible for their own exhibit and all items dealing with their exhibit.

Selling in the Stands:

Not permitted.
